This Indenture made the fifth day of July in the year our  
thousand eight hundred and seven between John and Asa  
Bailey of the County of Santa Rosa and State of Florida of the first  
part and Ebenezer B Riley of the town of Milton in the County of Santa  
Rosa and State of Florida of the second part. Witnesseth that the  
said party of the first part in consideration of the sum of "one thousand  
and three" hundred and "ninety" one dollars and thirty five cents  
lawfull money of the United States to them duly paid has sold and  
by these presents does grant and convey to the said party of the second  
part all the personal property herein mentioned to wit Ten yoke of  
oxen Nemy, Eddy, Bell and Parling with cart and all appertaining thereto  
Dabe and Ball Moad and Pally with cart and all appertaining thereto  
Mike and Pete Buck and Bright with cart and all appertaining thereto  
Ball and Moad Peck and Pally with cart and all appertaining thereto  
Lamb and Blige Park and Dallas with cart and all appertaining thereto  
with the appertinances and all the tithes and interest of the said  
parties of the first part therein. This grant is intended as a  
security for the payment of One thousand "three" hundred and  
"ninety" one dollars and "thirty five cents" due on the first day  
of September One thousand eight hundred and seven which  
payment if duly made will render this conveyance (void) and  
if default shall be made in the payment of the principal  
above mention then the said party of the second part  
and his assigns are hereby authorized to take into possession  
and to sell before the Court House door in the town of  
Milton Fla the property above granted or so much  
thereof as will be necessary to satisfy the amount then  
due with the cost and expences allowed by law giving  
Ten days notice thereof at the Court House aforesaid
