Whereas, at a sale of land by W. J. Williams, Tax collector of
the County of Santa Rosa, at Public Auction, at Milton, in the said County

one thousand eight hundred & ninety for the non payment of Taxes
levied and assessed thereon, for the year one thousand eight hundred &
eighty nine & which remained unpaid on the day of such sale, together
with the costs & charges due thereon, the following described Piece or Parcel
was (or was) sold to Elijah Padgett who was the best bidder
therefor, for the sum of one Dollar & Forty seven Cents, To wit,
Forty acres in S. E. Corner of South-half of N. W. 1/4 of Section
17 Township 2 Range 30, North West

which such sum was the whole amount of Taxes due & unpaid
on said Tract of Land for the year aforesaid, together with the interest
& cost due thereon, and the charges of such sale, and has been paid by
