This Agreement made and entered into between  
William V. Jernigan of the first part & Rufus Milligan  
Jas. A. Chaffin & Frank Jernigan of the second.  
Witnesseth that the said Wm Jernigan agree to relinquish and give, sell  
and convey all of his right, claim, title & interest of whatsoever kind unto all the lands  
lying on the east side of the three notch road running from and commencing at  
the South line of Township four (4) North of Range forty 28 nine West,  
running Northwards to the Cobb old field and thence to take the Pollard Road running  
North to Pollard Alabama. And further agree to cut out any Timber or Trees  
or Saw Logs, now to have any Timber, Trees, Saw Logs cut on the East side of the  
above described line or Road, & that he will to the best of his skill & ability  
protect and keep any one from cutting Timber, Trees or Saw Logs on any of the lands  
claimed and owned by the said Milligan, Chaffin & Jernigan.  
And the said P. Milligan, J. A. Chaffin & Frank Jernigan agree to relinquish  
& give sell and bargain all of their right, title & interest of whatsoever kind unto all  
the lands lying on the west side of the above described Line or Road.  
In case either party wants to sell any of these lands, they shall to whomsoever  
they shall sell have them to guarantee all the rights of this instrument of  
writing to either party.
