Santo Rosa County, JH Gibson of the State of Florida County of
Santo Rosa, for and in consideration of one dollar to me in
hand paid by Singer Holt & Geo A. Croon of the said State of
County the receipt whereof is hereby acknowledged and confirmed
have given granted bargained and sold and by their presents do
give grant bargain sell and assign unto the said Singer
& Holt & Geo A. Croon their executors administrators and assigns
all the following personal property being within the State and
County aforesaid and now in my possession and described as
follows to-wit: One Sugar Mill and Kettle, three head of Oxen mottled
with copper and half copper in one ear and swallowfoot & under bit in
the other ear, one of mottled with copper and upper and under bit in one
ear and over bit in the other ear, eight head of Swiss Cattle mottled
with under slope and over bit in one ear and swallow foot and
under bit in the other ear branded G and 125 head of sheep mottled
with swallowfoot and under bit in one ear and copper and half copper in
the other ear and branded with a strip brand across the nose
No horns and to hold said described personal property unto the said
Singer Holt & Geo A. Croon their executors administrators and
assigns to their use and behoof forever. And the said JH
Gibson for himself his executors and administrators do covenant
to warrant and defend the title to said described property
unto the said Singer Holt & Geo A. Croon their executors adminis-
trators and assigns against the lawful claims and demands
of all persons whomsoever. Now the above instrument is intended
as a mortgage the condition of which are that whereas the
said Singer Holt and Geo A. Croon have this day become surety for
JH Gibson upon three bonds each in the sum of Two Hundred
Dollars for the appearance of the said JH Gibson at the next
term of the Circuit Court to be holden in Santo Rosa County
State of Florida on the 25 day of March A.D. 1892
Now if the said JH Gibson do and appear at said Court as aforesaid and
from term to term thereof to abide the judgment of said Court, then
the obligation to be null and void else to be of full force and effect
and in case of foreclosure the said Singer Holt & Geo A. Croon are to be allowed
their reasonable attorneys fees which are included in and covered by
