 State of Florida, the receipt whereof is hereby acknowledged
 the said Pensacola & Atlantic Rail Road Company has
 granted bargained and sold and by their presents do grant
 bargain sell and convey unto said Joseph Norman
 and John Olson all the following tracts or parcels
 of land situated in the County of Santa Rosa State of Florida
 and described as follows to-wit: The North West quarter
 of the South west quarter of section fifteen (15) in
 Township one (1) North of Range twenty-eight (28)
 West. Containing Forty (40) Acres more or less
 To have and to hold unto the said Joseph Norman and
 John Olson their heirs executors and assigns forever.
 Now therefore in consideration of the premises the
 said Pensacola & Atlantic Railroad Company hereby warrant
 and defend the title in and to the aforesaid premises
 to the said Joseph Norman & John Olson in fee simple
 forever. And in pursuance of the third section in the
 mortgage executed by the said Pensacola & Atlantic Rail
 road Company to Edmund D Randolph and John L Cadwalade
 as trustees dated 1st April 1884 duly acknowledged
 and recorded, the said Randolph and Cadwalade
 hereby convey all their interest as said trustee in
 said land to the said Joseph Norman and John
 Olson this deed being as to them a quit claim as trustee
 and without warranty of title by them.
 In testimony whereof the said Pensacola & Atlantic Railroad
 Company has made and by authority of a resolution of
 its Board of directors signed this instrument by
 its president and attested the same by causing the seal
 of the Company to be affixed by its Secretary and the said
 Edmund D Randolph and John L Cadwalade trustees
 hereunto set their hands and seals on this the second
 day of August 1890
