Elizabeth the Widow of James Warner of ann Arundell County Exhibited the Last Will and Testament of the Said James Warner and Requested that Commission may Issue to Thomas Marsh of the said County to prove the Said Will and that Cornelius Howard and Richard Hill be appraisers which will is as followeth

I James Warner being weak in Body but yet in Sound and perfect Memory I make this my Last Will and Testimony I bequeath my Body unto the Earth from whence it Came & my Soul unto my Lord and Maker.

Item I bequeath unto my Wife Elizabeth Warner all moveables and unmoveables what soever I am now possest withal and after her disposing only the plantacon and Lands after her Dayes to my Daughter Johanna Sewell and her heirs for Ever and not to be disposed of to none from them but my Said Daughter and her heirs for Ever and unto my said Wife all Debts and Dues whatsoever to be at her whole disposing and So I finish and herunto Enterchangeable I hereuto Sett my hand and Seal this thritient day of ffebruary in the year of our Lord 1673

These may Certifie unto yo^r Hon^r that according to yo^r order the Last Will and Testament of James Warner Late of Ann Arundell County deceased was proved in Comon form to be his Real act and Deed, upon the Oaths of Abraham Childe and John Jacob the witnesses to the Said Will Sworn before me the tenth day of September 1674.
